- Rectifications on current buildings are in process. Nothing is unsafe. Example:
 the guard house was constructed out of compliance with current building rules.
 Appropriate certifications were not obtained at the time of previous construction
 projects. That means the buildings must be brought up to today's building code.
 Nothing is unsafe, but we have to comply with the current building code.
- Rectifications must be completed before the new building is used. Construction, rectifications, and demolition can all happen at the same time.
- We also need to update the electrical system on the campus.
- The new building is a good design. The new design meets the needs of the school. Cost is coming down, however cost will be firmer in the next couple of months. It's a simpler building, so should be a faster build. CAJ is working with a new architect who has designed schools in the past.
- Funding: true cost of the retificiations is not known. Might be asking for an increase in loan amount. If an increase is needed, it will be brought to the Board of Councilors and Board of Directors in May, 2019.
